RESIDENTIAL SOLICITOR, PEDDLER, CANVASSER REGISTRATION FORM
Ordinance #3670

Each person, business, firm or corporation, making personal contact with a resident at their residence without prior specific invitation or appointment for the primary purpose of attempting to obtain a donation to a particular charitable, religious, patriotic, civic, fraternal, social service or organization, educational institution, philanthropic, non-profit organization, welfare, benevolent, or for political purposes for the purpose of selling goods or services or distributing handbills or flyers for a commercial event or service, for enlisting support for or against a particular religion, philosophy, ideology, political party, issue or candidate, even if incidental to accepting donations of money for or against such cause, is required to obtain a license. Return this form to the City Secretary's Office, City Hall, City of Deer Park, 710 East San Augustine Street, Deer Park, Texas 77536 no later than the 12th calendar day prior to the event.

___ Residential Solicitor - **person attempting to obtain a donation** to a particular patriotic, philanthropic, social service, welfare, benevolent, education, civic, fraternal, charitable, political or religious purpose, even if incidental to such purpose there is the sale of some good or service, or (ii) distributing a handbill or flyer advertising a commercial event or service. **No fee.**

___ Canvasser – **person attempting to enlist support** for or against a particular religion, philosophy, ideology, political party, issue or candidate, even if incidental to such purpose the canvasser accepts the donation of money for or against such cause, or (ii) distributing a handbill or flyer advertising a non-commercial event or service. **No fee.**

___ Peddler – **person attempting to sell a good or service.**

A “peddler” does NOT include a person who distributes handbills or flyers for a commercial purpose, advertising an event, activity, good or service that is offered to the resident for purchase at a location away from the residence or at a time different from the time of visit. Such a person is a “residential solicitor”. **\$15.00 fee**
